Demonstrator vehicles may not be allowed back in the designated loading / unloading area until after the streets reopen. Demonstrator must request in advance if electricity is required. Failure to comply with all City of New Haven ordinances, site and event policies & procedures and/or New Haven Area Chamber of Commerce staff instructions or requests may be grounds for immediate expulsion from the event and preclusion from participation in future events. Demonstrator(s) grants permission for the use of his or her name and business name or likeness related to the Demonstrator's participation in any event conducted by the New Haven Area Chamber of Commerce. Demonstrator also grants the use of his or her voice and any and all recorded and or filmed/video/photographed footage of Demonstrator and or Demonstrator's display including art, and further waives all rights to any compensation, as a result of Demonstrator's name or Business name or likeness being used in any way. By signing this Release, the Releaser accepts and understands that, in consideration of the City allowing the Releaser to participate in the above-described activities, the Releaser waives any and all claims against the City, whether based on contract, negligence or otherwise, which may arise as any damages the Releaser may suffer as a result of his or her participation in the above described activities. Releaser releases the City, its officers, employees, agents and assigns regarding any claims, costs and expenses which arise out of the above-described activities. Should any provision of this Agreement be held invalid, illegal or unenforceable, it shall not affect or impair the validity, legality or enforceability of any other provision of this Agreement. I hereby represent that I have read, understand and agree to the contents of this Release and sign the same voluntarily.

Liability of Operators: In no case shall the officers, directors, and/or sponsoring agent of any New Haven Area Chamber of Commerce event or promotion be held responsible for any loss, damage, injury, theft, death, or from any other cause of any character, to any property or person while the same is on the event grounds.
